

## RELEASE AND WAIVER OF LIABILITY

- (a) The Player represents that he/she is over the age of 18 years (if the Player is a minor, a parent or guardian must also execute this form), and wishes to participate in sports activities, and recognizes and acknowledges that his/her participation in such activities involves the exposure to inherent risks and potential injury.
- (b) With full knowledge of the above and any other risks associated with sports participation, the Player hereby expressly and specifically assumes said risks, and agrees to waive any and all claims for personal injury, illness, death or property damage of any kind on behalf of myself, my heirs, personal representatives and/or next-of-kin which may arise against Lonestar (except Lonestar's negligence).
- (c) The Player expressly understands and agrees that this Release is intended to be as broad and inclusive as permitted by law and that this Release shall be governed by and interpreted in accordance with the laws of the State of New York.
- (d) I have read this Waiver and Release carefully and understand all of its terms, and agree to be bound hereby.**
